

**A: Hantering en beskerming van diere by skoue**

Die nasionale standaard vir die *Menslike hantering en fasiliteite vir die beskerming van vee by skoue, veilings, verkoop van diere en vee ponde*, ook algemeen bekend as SANS 1469: 2014 (uitgawe 1) was eenparig deur die Vee-welsyn koördinerings vereniging aanvaar. Die volgende 5 vryhede, soos uiteengesit in die relevante nasionale wetgewing, naamlik SANS 1469: 2014 (uitgawe 1), moet aangewend word: -

- Vryheid van dors, honger en wanvoeding
- Vryheid van ongemak
- Vryheid van pyn, beserings en siekte
- Vryheid om normale gedrag uit te druk
- Vryheid van vrees en angs

Telersgenootskappe, eienaars, hanteerders asook beoordelaars het almal 'n verantwoordelikheid om te verseker dat die bogenoemde punte nagekom word en alle partye kan, volgens wetgewing, geklassifiseer word as *verantwoordelike persone* sou die vasgestelde wet geskend word.

**B: Geen toegang met Vuurwapens**

Die Bloemfontein Skougronde, as gasheer van die jaarlikse Bloemskou, sal vir die duur van Bloemskou 2018, soos per die Wet op Vuurwapenbeheer, 2000, verklaar en gekategoriseer word as 'n vuurwapen -vry sone.

Dit was besluit deur die plaaslike Suid-Afrikaanse Polisie diens (SAPD) in die belang van openbare, sowel as in ooreenstemming met die objekte van die bogenoemde Wet. Die gevolge van so 'n verklaring, behels dat, niemand mag of kan: -

- Enige vuurwapens of ammunisie in 'n vuurwapenvry sone toelaat nie.
- Enige vuurwapens of ammunisie in 'n vuurwapenvry sone dra nie.
- Enige vuurwapens of ammunisie in 'n vuurwapenvry sone stoor nie.

'n Polisiebeampte kan sonder 'n lasbrief: -

- Enige gebou of perseel in 'n vuurwapenvry sone besoek indien hy of sy, op redelike gronde vermoed, dat 'n vuurwapen of ammunisie aanwesig is in die vuurwapenvry sone, in oortreding met die verklaring.
- Enige persoon aanwesig in 'n vuurwapenvry sone ondersoek.
- Beslag lê op enige vuurwapens of ammunisie aanwesig in die vuurwapenvry sone of op 'n persoon in oortreding met die verklaring.

*Bloemskou het met **Gerrie Coetzee Vuurwapens** by Senwes (oorkant die skougronde, Curielaan) ooreengekom om om wapens veilig daar te bewaar tydens die Bloemskou. **C: Terme en voorwaardes**

Neem asseblief kennis dat volgens Bloemskou regulasies; alle toetreders, deelnemers of uitstallers aan enige kampioenskap, kompetisie, vertoning of veiling wat enige vee insluit, moet die Terme en Voorwaardes wat gesirkuleer is, teken en / of bevestig dat hulle kennis neem en sal voldoen aan hierdie terme en voorwaardes wanneer hulle enige van die fasiliteite of infrastruktuur op die Bloemfontein Skougronde betree of gebruik van maak.



## **GENERAL SAFETY REGULATIONS** **BLOEM SHOW 2018 (Agri/livestock)**

### **A: Handling and protection of livestock at shows**

The national standard for the *Humane handling and facilities for the protection of livestock at shows, auction sales vending and livestock pounds*, also commonly known as SANS 1469:2014 (edition 1) was unanimously accepted by the Livestock Welfare Controlling Council (LWCC). The following 5 freedoms, as stated in the relevant national legislation, i.e. SANS 1469:2014 (edition 1), shall be applied:-

- Freedom from thirst, hunger and malnutrition
- Freedom from discomfort
- Freedom from pain, injury and disease
- Freedom to express normal behaviour
- Freedom from fear and distress

Breed societies, owners, handlers as well as judges all have a responsibility to ensure the above-mentioned points are adhered to and all parties can, as per legislation, be classified as *responsible persons* should the set law be infringed.

### **B: No access with Fire arms**

The Bloemfontein showgrounds, as host of the annual Bloemshow, will for the duration of Bloemshow 2018, as per the Firearms Control Act, 2000, be declared and categorized as a *Firearm –free zone*.

This was decided upon by the local South African Police Services (SAPS) in the interest of public as well as in accordance with the objects of the above-mentioned Act. The consequences of such a declaration, entails that, no person shall or may:-

- Allow any firearms or ammunition to be in a firearm-free zone
- Carry any firearm or ammunition in a firearm-free zone
- Store any firearm or ammunition in a firearm-free zone

A police official may without warrant:-

- Search any building or premises in a firearm-free zone if he or she has a suspicion on reasonable grounds that a firearm or ammunition may be present in the firearm-free zone in contravention of the declaration.
- Search any person present in a firearm-free zone
- Seize any firearms or ammunition present in the firearm-free zone or on person in contravention of the declaration
